SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures:

Request medical assistance immediately, showing the SDS of this product.

By inhalation:

This product does not contain substances classified as hazardous for inhalation, however, in case of symptoms of intoxication remove the person affected from the exposure area and provide with fresh air. Seek medical attention if the symptoms get worse or persist.

By skin contact:

By ingestion/aspiration:

Do not induce vomiting, because its expulsion from the stomach can be hazardous to the mucus of the main digestive tract, and also risk damage to the respiratory system through inhalation. Rinse out the mouth and throat, as they may have been affected during ingestion. In the case of loss of consciousness do not administer anything orally unless supervised by a doctor. Keep the person affected at rest.

5.1 Extinguishing media:

Product is non-flammable under normal conditions of storage, handling and use.
